#### SECTION 1 A:- PROCEDURE FOR SUBMISSION OF E-TENDER

The bidders are required to submit soft copies of their bid electronically on the e-Wizard Portal using valid Digital Signature Certificates.   by clicking on the link "Bidder Enrolment" as per portal norms.
- The bidders to choose a unique username and assign a password for their accounts. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the e-Wizard Portal.
- 3. Bidders to register upon enrolment their valid Digital Signature Certificate (DSC: Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India with their profile.
- 4. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse. # Other Eligibility Conditions (Item 12 of Section 1A)

- a) The Bidder should provide Documentary proof and compliance report as per section 4 that the Specifications for the servers are matching to the specifications given elsewhere in this document.
- b) The bidder shall have experience of at least 5 years in the field of Information Technology. This shall include specific experience in any or all of Design, Engineering, Integration, Operations, Maintenance & Consultancy in IT Networking & Server Installations independently, or as part of a large IT Infrastructure Project. The Bidder should provide proof that the bidder has 5 years' experience.
- c) The bidder shall have adopted appropriate quality systems (ISO 9001) and adhere to standards and best practices. The bidder / employees of the bidder should have appropriate expertise in design, engineering, integration, operations and management of IT Information Systems/Server Installations. The Bidder should provide proof that the bidder is certified ISO 9001.
- d) The bidder shall have executed at least 3 similar works during the last 2 years, in the supply and installation of similar equipments, as part of a IT Infrastructure Project belonging to Government or large Public Sector/Private Sector Organizations. The Bidder should provide proof that 3 similar supply and installations are carried out within the last two years.
- e) The bidder should provide Manufacturing authorization letter from OEM to participate in this tender process.
