#### Instructions to the candidates:

All the candidates who have been allotted a seat for B Tech Programme in NITK Surathkal and have accepted the same in ROUNDS 1-6 under JoSAA - 2020, are hereby required to complete the following steps after completion of 6<sup>th</sup> Round of JoSAA-2020.

In view of the COVID-19 Pandemic, the admission process will be conducted in online mode with following TWO Steps.

**STEP-1:** As instructed by CSAB -2020,during 9<sup>th</sup> - 13<sup>th</sup> November 2020, the candidates who have accepted an allotted seat at NITK Surathkal in ROUNDS 1-6 under JoSAA -2020 **and wish to retain their allotted seat, are required to pay the partial admission fee at JoSAA portal only, to secure the admission.** As communicated by CSAB - 2020, the partial admission fee is Rs. 40000/- for GEN, GEN-EWS, OBC-NCL and Rs. 20000/- for SC, ST, PwD candidates. The candidates are hereby informed to visit the following link <https://josaa.nic.in/webinfo/File/GetFile?FileId=24&LangId=P> for more details on the payment of partial admission fee and instructions on reporting at the JoSAA portal.

As instructed by CSAB-2020, failure to pay the partial admission fee and reporting at the JoSAA portal during 9<sup>th</sup> -13<sup>th</sup> November 2020, would lead to cancellation of the seat.

**These candidates are not required to report at NITK for online admission during this period (9<sup>th</sup> to 13<sup>th</sup>, November, 2020).**

**STEP-2:** Further as per the updated JoSAA-2020 schedule the **candidates who have completed Step 1 are required to report online at NITK during 16<sup>th</sup> - 21<sup>st</sup> NOVEMBER 2020, for completing the admission formalities.** Due to the COVID-19 pandemic situation, the admission of the candidates at NITK would be done online

**However, the candidates who want to participate in CSAB special rounds, need not complete Step 2 of admission at NITK during 16<sup>th</sup>-21<sup>st</sup> NOVEMBER, 2020.**

All such candidates who have completed Step 1 after payment of Partial admission fee at JoSAA portal, will be sent the login details for the admission portal of NITK through the email id registered in the JoSAA portal. The online Admission portal of the Institute will be made live from November 16, 2020 (Monday) to fill-up the Online Admission form after the payment of the balance Institute fee.

Candidates are advised to fill their details through the NITK IRIS portal by logging in, at the MIS link <https://iris.nitk.ac.in/admission/admissions/login> and upload the documents listed below after the payment of the balance Institute fee at the IRIS portal for admission at the institute. The details of fee to be paid are given below. The online document verification by NITK officials will be carried out during 16 - 21, November 2020 and Provisional Admission Orders will be issued to the candidates online on or before 22<sup>nd</sup> November 2020.

**The scanned copies of the following Original documents are to be uploaded by the candidate at the time of online reporting for admission at the Institute**

1. Document verification letter/final reporting letter downloaded from the JoSAA portal, after paying the partial admission fee, between November 9 – 13, 2020.
2. Proof of payment of balance fee to the Institute
3. Score Card of JEE (Main)
4. Admit Card of JEE (Main)
5. Photo ID proof as per Govt. of India norms (Copy of Aadhar Card is compulsory)
6. Original Certificate of Date of Birth issued by competent authority/Class X (High School) Board Certificate as proof of date of birth
7. Original Mark sheet of Class XII
8. Medical Certificate in the format provided.
9. Original Certificate of category (OBC-NCL/SC/ST), if applicable, as per Government of India, issued by the competent authority. In case of OBC category, the certificate must be issued on or after April 1, 2020
10. Original Income and Assets Certificate for EWS candidates, if applicable, as per Government of India, issued by the competent authority. The certificate must be issued on or after April 1, 2020.
11. Original Certificate for Persons with Disabilities (PWD), if applicable, issued by the competent authority.
12. Undertaking to be submitted by PWD candidate in the format provided
13. Original Migration certificate of last institute/university attended
14. Original Conduct Certificate from head of the institution last attended
15. Original Transfer certificate from the head of the institution last attended
16. Passport size photograph.

(If any certificate is in language other than Hindi or English or Kannada, translation of the same in English is to be produced with certification by the competent authority)

## Hostel Facility

- (1) Candidates belonging to OBC –NCL or EWS category are required to submit the certificates in the prescribed format available in the JoSAA website and issued on or after April 1, 2020.
- (2) Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in the case of SC and OBC-NCL category) and Tribal Welfare Department (in the case of ST category) of Maharashtra Government.
- (3) The candidates who belong to PWD category must submit the certificate issued from a competent authority in the prescribed format available in the JoSAA website. **The certificate which is other than the prescribed format will not be accepted. They also need to submit an undertaking along with the certificate, in the prescribed format provided.**
