1. Qualification: Ph.D./ Master's Degree (M.E./ M.Tech. or equivalent) holders with first class in respective discipline and GATE qualified candidates preferred.
2. The age limit for the candidate is 60 years.
3. Consolidated Pay:
 - a) For those with Ph.D. - **Rs.50,000/- per month.**
 - b) For those with a Master's Degree (M.E./ M.Tech. or equivalent) - **Rs.40,000/- per month.**
4. No other allowances are admissible.
5. Nature of appointment: The appointment is purely temporary for one semester.
6. The interested candidates have to attend walk-in-interview along with a filled-up application form and self-attested necessary documents (Original & Xerox Copy).
7. Reservation will be as per Government of India Norms.
8. If applicable, the candidates are required to enclose their valid Community Certificate in the prescribed format.
9. The selected candidates will be required to join immediately.
