This has been clearly mentioned under Para-9 / Page No.23; and Note:04, Page No.48 of Tender Document. The bidders are requested to refer the same.
2	Sir it is mentioned in the quote that a shift means that it is a continuous working period of eight hours. And likewise a day means a period of 24 hours which starts at midnight. And the rate is also ask by the NIT to quote is per person per day. So please clarify whether the work is in three shifts or only one shift in a day.	The shift timing is as per the actual requirements of the concerned departments/sections, where the workforce is deployed.
3	Reference to the experience criteria Sr. No. 10.5 under clause Minimum eligibility criteria for qualifying in Technical bid it is mentioned that the bidder have successfully completed similar works i.e. Skilled workforce (other than Security and Housekeeping workers) as follows:  (i) A minimum of one single similar service with manpower not less than 216 numbers per day.  OR  (ii) A minimum of two single similar services – each service with manpower not less than 162 numbers per day.
