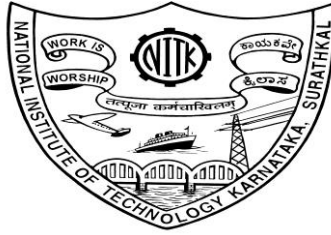

The experimental set-up to measure the transmissibility ratio of a vibrating table under the influence of an unbalance. The set-up should be capable of indicating the transmissibility ratio through digital read out.

- Weight : 15 kg Approximately
- Overall Size : 300 x 100 x 200mm
- Motor : 1 / 10 HP , DC 1500 RPM Max
- Springs : To Suit Weight of Motor Table
- Load Cell : 0 - 20 kg Strain Gauge Type
- Indication : By Blinking LED (Bar Graph)
- **Warranty Period : 02 Years**

- An instruction manual consisting of experimental procedures should be provided along with the apparatus.
- The whole set-up should be well designed and arranged on a rigid structure painted with industrial PU paint.
