Terms and Conditions

1. The rates should preferably be quoted on a FOR destination basis for services to be rendered within India.
2. The bidder shall clearly indicate any applicable tax exemptions, including GST exemptions, if applicable to the services offered.
3. The rate quoted should be on a unit basis (where applicable). Taxes and other statutory charges should be quoted separately, considering exemptions if any. The rate should be quoted in INR only.
4. The rate quoted should be inclusive of all service-related components, including deployment, execution, testing (if applicable), commissioning (if applicable), implementation, documentation, and training, as required under the scope of work.
5. Payment: No advance payment will be made. Payment will be released only after satisfactory completion of the services in accordance with the contract terms and submission of the required performance security by the service provider.
6. The guarantee/warranty period (where applicable) for the services provided should be clearly specified. The complete period should be indicated in Section 3 of this tender document.
7. The required timeline for commencement and completion of services should be specified in Section 3 of this tender document.
8. In case of dispute, the matter will be subject to Mangalore Jurisdiction only.
9. **Delivery Period:** The Delivery Period/Time shall be deemed to be the essence of the Contract and delivery must be completed not later than such date(s). If the Supplier does not perform its obligations within the Delivery Period/Date mentioned in the Contract, the same would constitute the breach of the Contract and the Institute shall have the right to cancel or withdraw the Contract for the unsupplied portion after the expiry of the original or extended delivery date or period stipulated in the Contract. Such cancellation of the contract on account of non-performance by the Supplier would entitle the Buyer to forfeit the EMD/Performance Security besides other actions such as debarment from the Institute as per GFR 2017.
10. **Liquidated Damages:** Timely delivery is the essence of the contract and hence if the Supplier fails to deliver Goods within the original/extended delivery period(s) specified in the contract, the Institute will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, **@ 1% per week or part of the week of the delayed period** as pre-estimated damages not exceeding 5% of the contract value without any controversy/dispute of any sort whatsoever.
11. The bidder needs to comply with restrictions under rule No 144 (xi) of GFR (General Financial Rules) 2017 and the clause pertaining to Public Procurement Division Order (Public Procurement no 1,2 & 3 vide ref. F.No.6/18/2019-

PPD dated 23.07.2020 and 24.07.2020 of Dept of Expenditure (DOE), Ministry of Finance). In this Connection Bidder has to submit Self Certification (as per Annexure A or B), depending on the status of the bidder.

12. The bidder needs to submit a Self-certification in line with Make in India, Public Procurement Order No. P-45021/2/2017-BE-II dt. 15.06.2017, P 45021/2/2017-PP (BE-II) dated 28.05.2018, P-45021/2/2017-PP (BE-II) dated 29.05.2019 and P45021/2/2017- PP (BE – II) dated 16.09.2020 of DPIIT, Ministry of Commerce & Industry. The Bidder who will not meet this criterion will be rejected in the technical bid. The Self-certification should be provided as per Annexure C.

13. EMD must be in the form of Bank Guarantee **Annexure-D** (DD/e-Payment mode through Net Banking). It will be valid for 180 days from the date of opening of the tender. In case of EMD payment made through E-Payment, UTR Number with details should be uploaded. The firm registered with MSME/NSIC as per MSME procurement policy order 2012 will be exempted from submission of EMD. Intended parties will have to give proof of registration along with their tender. EMD of the unsuccessful bidders shall be refunded without any interest at the earliest after finalization of the purchase of the concerned item.

a. The EMD will be returned to the BIDDERS(s) whose offer is not accepted by NITK within one month from the date of the placing of the purchase order(s) on the selected BIDDER(s). In the case of the BIDDER(s) whose offer is accepted the EMD will be returned on submission of Performance Security in the form of Bank Guarantee (BG). However, if the return of EMD is delayed for any reason, no interest/penalty shall be payable to the Bidders.

The scope of work shall be for a particular sub activity under the activity 1 of the entire study. The scope of work is as below:

Sub activity A: Survey, Research and Analysis for Mangalore Region

- Stakeholder Mapping & Data Collection
 - Identify and engage all major actors: dairy farmers/cooperatives, logistics providers, processors, retailers, and regulators.
 - Conduct field surveys and interviews (using structured questionnaires and web-based surveys) to collect data on supply chain practices, operational challenges, fleet types, and logistics costs.
- Supply Chain Mapping & Process Review
 - Document all stages: milk collection centers, transport to processors, processing, packaging, distribution, and retail delivery.
 - Map transport flows (routes, truck types) and analyze fleet utilization, cost breakdown (fuel, maintenance, labor), and bottlenecks.
- Performance and Financial Analysis
 - Calculate operational KPIs (cost per kilometre/litre, supply chain delays, loss rates, energy intensity).
 - Tabulate all the assumptions required for developing a Total Cost of Ownership (TCO) for current vs. electric trucks: upfront costs, operating costs, energy expenses, lifecycle maintenance, and charging infrastructure.
 - Tabulate all the assumptions required to calculate Internal Rate of Return (IRR) and payback for transition to e-trucks using financial modelling, scenario analysis, and comparative cost/benefit tables.
- Environmental and GHG Analysis
 - Assess baseline GHG emissions from transportation of the milk and its related products for the particular zone based on GHG Protocol / relevant ISO codes.

These activities shall be done based on ground surveys and stakeholder consultations whenever necessary.
